Rob Stone was present to discuss last month activities. There were 6 fire calls last month. The new truck will be in service next Wednesday. It is in limited service now and offsite currently. There was a request

to fill a swimming pool that is not in the township and are willing to pay \$70 per truck load. The board is concerned that there will be more damage done to the property and do not want to be liable for it.

There was a sinkhole on the Schwichtenberg property again but did not affect the dike this time. MnDOT and the Corp of Engineers were present. A broken pipe was found and temporarily fixed until the river is at a safe level. MnDOT will be coming back to fix the pipe properly and more bad pipe that was discovered.

Retaining a township attorney was discussed. Jerry spoke with a few firms in town and suggested going with Kennedy & Kennedy Law Firm. Roger made a motion to accept Kennedy & Kennedy as the township attorney. Dennis seconded the motion. All voted in favor and the motion carried.

Doug announced that he will be deploying in February 2015 for 6 months. He has asked a resident, June Lonnquist, to sit in his seat while he is on leave if the board approved it. This will be discussed at next month's meeting.

Dennis made a motion to adjourn. Roger seconded the motion. All voted in favor and the motion carried. Meeting adjourned at 9:19 pm.
