Ordinance Number 5 ORDINANCE REGULATING THE CONDUCT OF JUVENILES

The Town Board of South Bend do ordain as follows:

Section 5.01 CURFEW FOR MINORS UNDER AGE OF 16

It shall be unlawful for any minor under the age of 16 years to be in or upon the public streets, alleys, parks, playgrounds, or other public grounds, public places and public buildings, places of amusement, entertainment and refreshment, vacant lots, or other places open to the public between the hours of 10:30 P.M. and 5:00 A.M. of the following day, unless such minor is accompanied by his or her parents, guardian or other adult person having the direct care and custody of the minor.

Section 5.02 CURFEW FOR MINORS UNDER AGE OF 18 AND OVER AGE OF 16

It shall be unlawful for any minor under the age of eighteen years and over sixteen years to be in or upon the public streets, alleys, parks, playgrounds, or other public grounds, public places and public buildings, places of amusement, entertainment and refreshment, vacant lots, or other places open to the public, between the hours of 12:00 midnight and 5:00 A.M. the following day, without reasonable excuse unless such minor is accompanied by his or her parents, guardian, or other adult person having the direct care and custody of the minor.

Section 5.03 SENIOR HIGH DANCE HOURS

For attending the annual Junior-Senior Prom and/or the annual Homecoming D nce sponsored by and for any senior high schools in the City of Mankato, minors may be permitted to be in the otherwise prohibited places until 2:00 A.M. provided a list of all such minors so attending is turned over to the Mankato Police Department and certified to by proper school authorities at least two days prior to the event in question. This section shall not be construed to permit such extension of hours if the parents or custodian of said minor expressly object thereto and make their objections known to the Mankato Police Department or South Bend Constable prior to the event in question.

Section 5.04 PARENTS RESPONSIBILITIES

It shall be unlawful for the parents, guardian, or other person having the direct care and custody of a minor under the age of eighteen years to permit such minor to violate the provisions of this section; provided, however, that the provisions of this section shall

not apply unless the Mankato Police Department or South Bend Constable has notified the parents, guardian, or other person having the direct care and custody of the minor in writing or in person, of a prior violation of Section 5.01, 5.02, or 5.03 of this ordinance committed by said minor.

Section 5.05 LOITERING

It shall be unlawful for minors to congregate or loiter in or around public places of business at any time without permission of business agents.

Section 5.06 PENALTY

Any person, firm or corporation who shall violate any of the provisions of Sections 5.01-5.05 of this ordinance upon conviction thereof, shall be guilty of a misdemeanor and shall be punished by a fine not exceeding \$100.00 or by imprisonment in the city or county jail for a term not exceeding 90 days. If the violator be a minor he shall be turned over to the parent, guardian, or custodian of such minor or remain in the custody of the police officers or Sheriff officers until the parents, guardian or custodian have been notified and have called for him. Upon any second or subsequent offense by a minor, the matter shall be referred to the juvenile court as provided by law.

Section 5.07 PENALTY

All ordinances and parts of ordinances in conflict with provisions of this ordinance are gereby repealed and if any part of this ordinance shall be declared invalid by court of competent jurisdiction, such judgement shall not invalidate the remainder of this ordinance.

Section 5.08 PENALTY

This ordinance is not to be construed to give minors the right to stay out until the maximum curfew hours as designated herein, but all minors are at all times subject to parental and other legal control.

Section 5.09 JUVENILES UNDER AGE OF 18 NOT TO OPERATE PINBALL MACHINES

It shall be unlawful for any person, firm or corporation to direct, suffer, or allow, knowingly or unknowingly, with or without his consent, a pinball machine or similar device to be operated or played by any person under the age of eighteen (18) years at any time or place within South Bend Township.

Any person, firm, or corporation violating any of the provisions of this ordinance shall be upon conviction thereof by any Court having competent jurisdiction, be punished by a fine not exceeding \$100.00 or by imprisonment in the County Jail for a term not exceeding 90 days.
